What is an access and participation plan?

An access and participation sets out provisions that will be meaningful and effective in promoting equality of opportunity for underrepresented groups, as determined by the Office for Students.

Key points

The <u>University of Central Lancashire</u> is a large higher education provider with UK campuses in Preston, Burnley and Westlakes. We have a large network of partner colleges in the surrounding regions and offers flexible provision including degree courses and apprenticeships.

The focus of our access and participation plan is on improving access to higher education for specific groups of students and improving their outcomes. Data shows that outcomes are lower for some groups of students compared to their peers at the University.

We want to partner with schools to improve pupils academic outcomes and attitudes towards higher education, with the aim of increasing the number of pupils from backgrounds underrepresented in higher education, accessing university.

When at the University, we recognise that students from areas of disadvantage, Black students, and mature students do not perform as well as other students. We will improve the outcomes for these student groups by delivering a range of support activities.

Fees we charge

At the University of Central Lancashire, the maximum fees charged per year are:

- £9,250 for full-time UK students
- £6.930 for part-time UK students

Financial help available

We offer financial advice and support to students from underrepresented groups. This helps students access higher education and continue studying until their course is completed. The support includes:

- Targeted financial support for students from low income households: from September 2025, students whose main household has an annual income of less than £25,000 a year will be entitled to a financial bursary. The bursary is £500 for each year of study, except the final undergraduate year, which is £750.
- A hardship fund that supports students facing financial hardship, including emergency payments for unexpected financial crisis.
- A range of targeted bursaries to support specific student groups.

Information for students

What we are aiming to achieve

Our overall aim is to enable people, no matter their background, to fulfil their potential and meet their life and career goals.

We have identified several key risks to equality of opportunity:

- School pupils from low income households are less likely to achieve a Grade 5 at Maths and English at GCSE. This is a larger issue in Lancashire where the gap between disadvantaged pupils and their peers is greater than the rest of the England.
- Mental health issues such as anxiety, depression, and stress are more prevalent among students from low income households. This makes it more difficult for these students to succeed academically and progress through their studies.
- Mature students, many of whom have been out of the education system for several years, face challenges transitioning into HE. Negative trends in continuation and completion rates underscore the need for comprehensive academic and personal support systems.
- The awarding gap between Black and White students at the University indicates a lack of adequate academic and personal support for Black students, which hinders their academic success.

Based on assessment of our performance, we have identified the below targets:

- **Target 1:** increase the number of pre-16 pupils eligible for free school meals reporting improved academic self-efficacy.
- **Target 2:** increase the number of pre-16 pupils eligible for free school meals reporting improved attitudes towards HE.
- Target 3: improve the completion rate for students from areas of disadvantage by 2028/29.
- **Target 4:** reduce the completion gap between disabled and non-disabled students from 4.8% in 2021/22 to 1.5% by 2028/29.
- Target 5: reduce the continuation gap between young and mature students from 8.2% in 2021/22 to 4% by 2028/29.
- **Target 6:** reduce the awarding gap between Black and White students from 24% in 2021/22 to 12% by 2028/29.
- **Target 7:** improve the progression rate into graduate employment for students from areas of disadvantage by 2028/29.

What we are doing to address keys risks to equality of opportunity

In partnership with our Students' Union, we have designed activities for each target which are summarised below:

- **Target 1 activities**: increase pupils' motivation to engage with school and college study and to increase academic confidence by improving study skills.
- **Target 2 activities**: bring pupils onto campus to make university a more familiar setting and guidance workshops about university and how school subjects link to courses at university and different careers.
- **Target 3 activities**: help transition into university and provide effective personal, academic and mental health support to students to ensure they are supported to succeed.
- **Target 4 activities**: provide tailored advice and financial support to disabled students and ensure staff have access to disability specific-training to provide effective support.
- **Target 5 activities**: help mature students return to learning if they are studying after a break and provide support on how to balance mature students' common additional commitments such as childcare and part-time working.
- **Target 6 activities**: build belonging and inclusion for Black students and wider university improvements such as ensuring our curriculum and assessment is diverse.
- **Target 7 activities**: improve part-time work and placement opportunities for students and provide financial assistance for students to engage in career development opportunities.
